Follow this step-by-step process to develop an inventory, create a Climate Action Plan, implement policies, monitor success towards achieving goals, and recognize achievement.

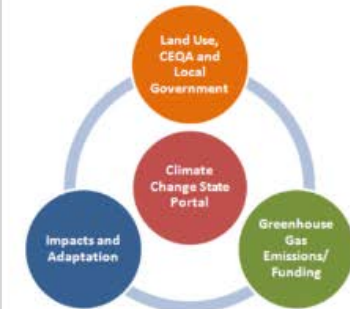

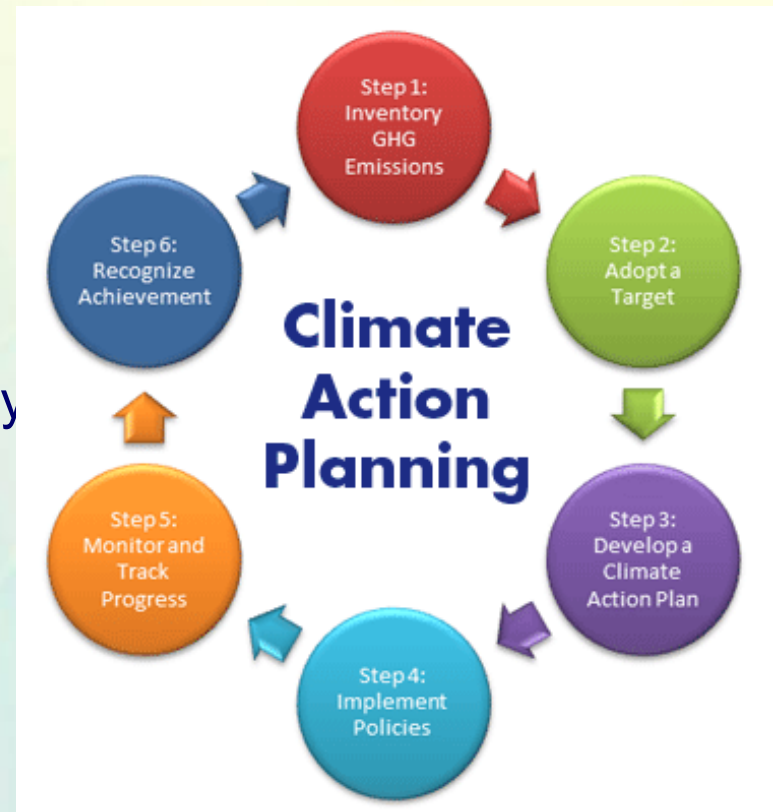

UC Berkeley/ARB CAP Decision Support Tool Data Collection Efforts

- Collected GHG emission reduction and cost data for over 90 measures
- Data can be used to analyze & select climate action planning (CAP) measures to reach goals
- Provide transparency for data sources, calculations and assumptions
- Integration into existing CAP tools

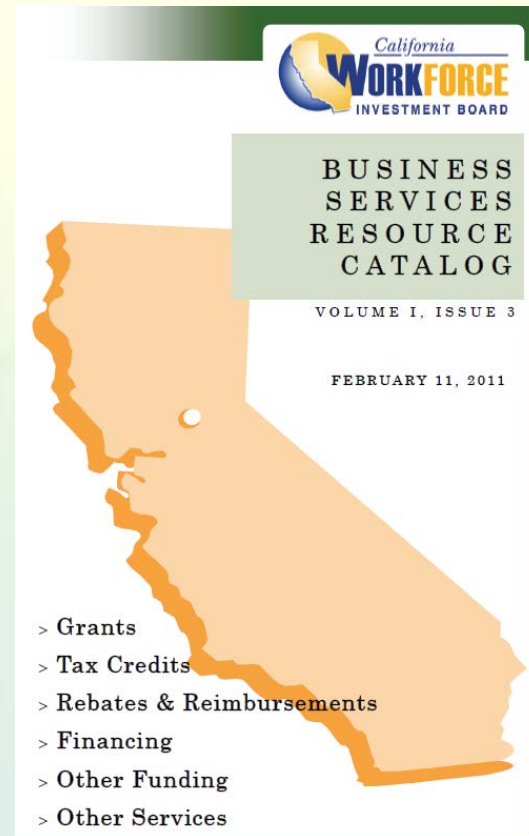

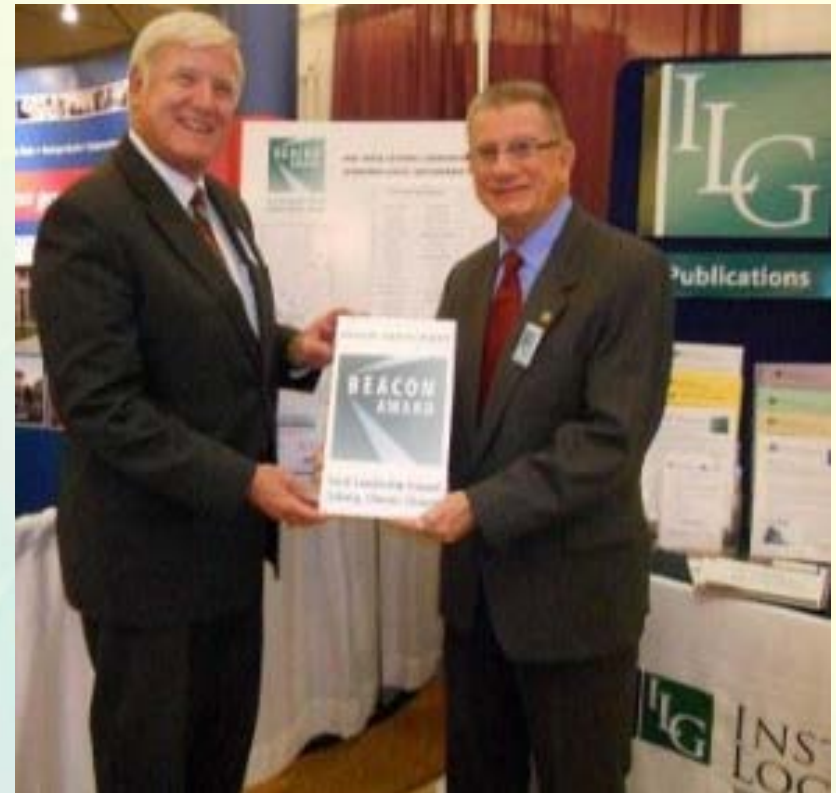
